I am pleased to present the Hartselle Police Department's 2015 Annual Crime Report. The Hartselle Police Department is dedicated to provide quality law enforcement services to our community. The information in this report and the charts provide statistical information concerning crime in Hartselle.

Our department continues to meet challenges of a growing community. The police department responded to 11,487 calls for service during 2015. The average response time to emergency calls for service is 2.5 minutes. Overall, Part 1 Crimes decreased by 5 percent. Total Part 2 Crimes increased by 9 percent.

In closing, I would like to publicly acknowledge the excellent job done by our officers and civilians on a daily basis. Their commitment and dedication to the citizens of Hartselle has made a major difference and has greatly contributed to these results.

Uniform Crime Reporting National Incident-Based Reporting System

In reporting crime statistics to the state and federal level, the Hartselle Police Department utilizes the National Incident-Based Reporting System (NIBRS). In this system, law enforcement agencies collect and submit detailed information about crime incidents and arrests. Most local law enforcement agencies provide a monthly count of offenses and arrests for certain offense categories to their state UCR systems, which in turn report these totals to the FBI.

The Hartselle Police Department reports violations of criminal law as either Part 1 or Part 2 crimes. The data presented on page 5 shows a yearly comparison of all crimes reported in Hartselle – both Part 1 and Part 2.


The Part 1 crimes reported by the Hartselle Police Department are homicide, rape, robbery, aggravated assault, burglary, theft, and motor vehicle theft.


Part 2 crimes encompass all other offenses which include criminal mischief, DUI, drugs/narcotics, forgery/counterfeit, fraud, liquor law violations, sex offenses, simple assault, weapons law violations, public order crimes and other miscellaneous offenses.







Clearance Rate for 2015

Clearance and arrest data are also reported to Alabama's UCR. A crime is considered cleared, either by arrest or by exceptional means, when enough evidence is found to charge a suspect and take him/her into custody. It is conceivable that one arrest could clear several offenses or that several arrests could clear one offense. The clearance rate is achieved by taking the number of clearances over the number of crimes reported.
